1. CALL TO ORDER

Chairman Gallagher called the meeting to order at 1:07 p.m.

2. ROLL CALL

Mr. Gallagher asked Deputy Clerk Carter to call the roll. Committee members Gallagher, Byrne and Kelly were in attendance and a quorum was determined. Committee member Simon was in attendance after the roll was taken. Committee member Conwell was absent from the meeting. Council President Jones was also in attendance.

3. PUBLIC COMMENT

There were no public comments given.

4. APPROVAL OF MINUTES FROM THE MARCH 5, 2024 MEETING

A motion was made by Mr. Byrne, seconded by Mr. Kelly and approved by unanimous vote to approve the minutes from the March 5, 2024 meeting.

5. MATTERS REFERRED TO COMMITTEE

- a) R2024-0104: A Resolution awarding a total sum, not to exceed \$10,000, to the Cleveland Family Center of Missing Children and Adults for the Northeast Ohio AMBER Alert Committee training event from the District 8 ARPA Community Grant Fund; and declaring the necessity that this Resolution become immediately effective.

Mr. John Majoy, Chief of Police for the Village of Newburgh Heights and Chairman of the Northeast Ohio AMBER Alert Committee, addressed the Committee regarding Resolution No. R2024-0104. Discussion ensued.

Committee members and Councilmembers asked questions of Chief Majoy pertaining to the item, which he answered accordingly.

On a motion by Ms. Simon with a second by Mr. Byrne, Resolution No. R2024-0104 was considered and approved by unanimous vote to be referred to the full Council agenda for second reading.

- b) R2024-0135: Resolution awarding a total sum, not to exceed \$27,000, to the City of Euclid for the Euclid HOPE Task Force from the District 10 & 11 ARPA Community Grant Funds and declaring the necessity that this Resolution become immediately effective.

Ms. Pam Turos, Co-founder of the City of Euclid HOPE Task Force, addressed the Committee regarding Resolution No. R2024-0135. Discussion ensued.

Committee members and Councilmembers asked questions of Ms. Turos pertaining to the item, which she answered accordingly.

On a motion by Ms. Simon with a second by Mr. Byrne, Resolution No. R2024-0135 was considered and approved by unanimous vote to be referred to the full Council agenda for second reading.

WHEREAS, Contract No. 228 with The MetroHealth System for Correctional Health Care Services for the Cuyahoga County Jail System for the period 5/9/2019 – 5/8/2022 was amended to extend the time period to May 8, 2024 and for additional funds in the amount not-to-exceed \$30,056,224.00; and

WHEREAS, the County Executive/Sheriff Department has recommended an amendment to Contract No. 228 with The MetroHealth System to extend the term to January 31, 2025, to add funds in the amount not-to-exceed \$24,931,847.00, and to transfer ownership of the jail pharmacy to The MetroHealth System; and

WHEREAS, the primary goal of this project is to provide medical services to the detainees of the Cuyahoga County Corrections Center mandated by ORC 5120:1-8-09 which mandates medical, dental and mental health services to all County Jail inmates; and

WHEREAS, this project is funded 100% by the General Fund Jail Health Care; and

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County entity.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council authorizes an amendment to Contract No. 228 with The MetroHealth System for Correctional Health Care Services for the Cuyahoga County Jail System for the period 5/9/2019 – 5/8/2024 to extend the term to January 31, 2025, to add funds in the amount of \$24,931,847.00, for a total not-to-exceed amount of \$110,915,111.00, and to transfer ownership of the jail pharmacy to The MetroHealth System.

SECTION 2. If any specific appropriation is necessary to effectuate the amendment described herein, such appropriation is approved, and the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.

SECTION 3. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 4. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
